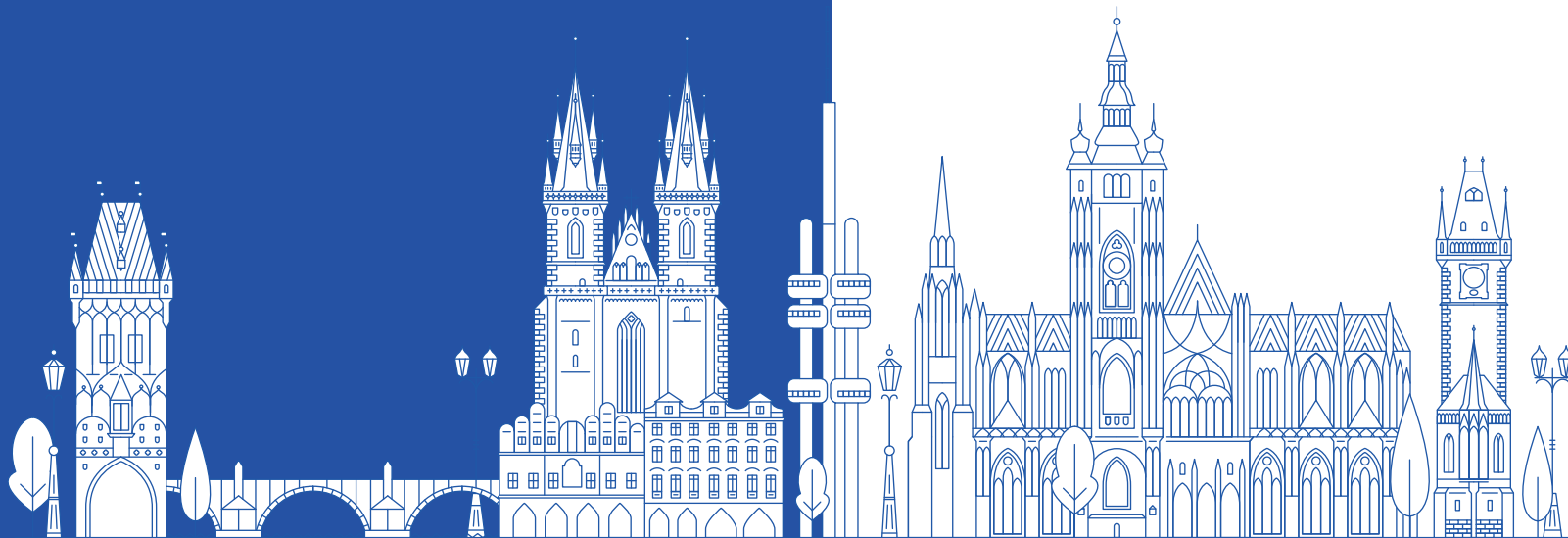

Who attends: 150-250 participants

Each MINEX Europe Forum brings together around 150-250 representatives from 20 to 30 countries in Europe, North America, Australia, and Asia. Over half of the participants are actively involved in exploring and developing mining projects, while around a quarter work at innovation and technology companies. Other participants come from academic and research institutions, NGOs, financial services, and national and central governments.

A large majority of MINEX Europe Forum participants hold positions responsible for decision-making processes and projects at the board and management levels.

What to expect: Forum, Trade & Investment Exhibition, Site visits

The 8th MINEX Europe Forum will be held on the 22 and 23 October in Prague featuring the two-day conference programme and on-site exhibition show-casing mining projects and technologies.

Trade and Investment Exhibition organised alongside the Forum's staged as a "universal cross-category marketplace" to facilitate interaction between suppliers of technologies & services with the representatives from companies operating mining projects across Europe.

On 24 October the Forum participants will be offered an opportunity to visit one of the regions near Prague and to learn from the experiences of the Czech Government programme on post-mining reconciliation.

About MINEX Forum™

The MINEX Europe Forum was established in 2015 when there were only a few who dared to explore Europe's mineral resources and discuss the mining Renaissance, amidst the "not in my backyard" public discourse. Much has changed over the last decade, but there is still much to be done to enable the enactment of the policies into local action. Many miners and mining projects continue to face procedural red tape and setbacks across Europe.

With the previous editions held in Austria, Serbia, North Macedonia, Bulgaria, Albania, and Poland, the Forum has stimulated cross-border dialogue on sustainable mining practices and developing projects spanning Southern, Northern, Central, and Eastern Europe.

The Forum assembles delegates from mining, technology, investment, and policy-making organisations, facilitating crucial discussions on sourcing primary raw materials sustainably to meet European industrial demands. It also examines the implications of key policies such as the European Critical Raw Materials Act, Just Transition, Green Deal and coal phase-out on the mining industry's future.

MINEX Europe 2024 objectives

The revival of mining and mineral exploration in Europe has become a hotly debated topic since the escalation of trade disputes with China and the disruption of critical raw materials and energy supplies from Russia and Ukraine. The future of the green transition, climate change, and the competitiveness of industries—from automotive to energy—depends on securing essential minerals and metals. The EU's Critical Raw Materials Act, introduced on 16th May 2024, combined with the Green Transition Act, is seen as a catalyst for Europe's Mining Renaissance. However, beyond efforts from central governments, collaboration between national governments, local authorities, and communities is crucial for implementation. The realities of revitalising the European mining industry vary across regions. While Nordic countries—such as Finland, Sweden, Norway, and Greenland—are actively implementing mining development plans, their counterparts in Southern, Eastern, and Central European countries struggle to secure financial, social, and political capital for existing and new mining projects. Moreover, some countries with century-old mining traditions have shifted away from supporting mining and are focusing on closing mines and diversifying into less socially challenging economic activities.

Breaking through the "bubble of silence" that often surrounds sensitive issues and politicised decisions on enabling "Mining in Europe" is one of the key objectives of the 8th MINEX Europe Mining and Exploration Forum, taking place in Prague on 22-23 October.

Drawing from our previous events held across the Western Balkans and Central Europe, we believe that the MINEX Europe Forum will provide an unbiased platform for an urgently needed professional, frank and open-minded discussion on the current challenges and potential solutions for the mining and mineral exploration sector and its role in securing Europe's requirements for essential metals and minerals while introducing the highest standards in mining and post-mining reconciliation.

VISIT TO THE URANIUM MINING AND URANIUM PROCESSING PLANT O. Z. TÚU NEAR STRÁŽ POD RALSKEM



ABOUT

o. z. TÚU is managed by DIAMO, a state-owned enterprise based in Stráž pod Ralskem, and is responsible for managing the environmental impact of past uranium, ore, and coal mining activities in the Czech Republic. Since 1996, the Uranium Mining and Uranium Processing Plant (o. z. TÚU) in Stráž pod Ralskem has been carrying out mining activities – the liquidation of deep and chemical (i.e. underground leaching of uranium through drilling from the surface) uranium mining.
